

Dairy Farmers of Washington 2022 Seahawk Ticket Sweepstakes Rules

Please read these Official Rules before entering this promotion (the "Promotion"). By participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION.

1. **Eligibility.** The Promotion is open only to legal residents of Washington state, age 18 or older and who follow @WADairy on Instagram. In addition, upon entering the Promotion, at the time of the drawing, and if asked to provide an affidavit of eligibility following the drawing, have: a user account on Instagram and "follow" Dairy Farmers of Washington (@wadairy) on Instagram and tag at least one (1) friend. If you do not meet any of these requirements, or any other eligibility requirements in these Official Rules, you are not eligible to win a prize, and the Dairy Farmers of Washington ("Sponsor") reserves the right not to award prizes to you.  - (b) After following @wadairy, users must comment on the featured post and tag who they'd like to bring to the game with them. The person being tagged does not have to respond or be following to be entered into the Promotion.
